

## Terms and Conditions of Accepting a Christian Projects Grants Programme Grant

### The following conditions apply to all Christian Projects Grants Programme grants:

- The grant must be used for the purpose for which it was awarded; the offer letter will clearly state what the grant has been awarded for. If the grant has been awarded towards the “running costs.....” additional conditions apply (see below).
- You must send us a bank statement which is no more than 3 months old. Due to the Coronavirus outbreak we are accepting scanned statements by email, or other appropriate third-party reports (e.g. from online banking) which clearly set out your banking details - Sort Code, Account Number and Account Name. Please ensure that two Trustees are included as recipients of the email you send to us. On receipt, we will ensure that your details are stored securely and will inform you by email when a payment has been made to you.
- The first payment of your grant must be drawn down within 12 months of the date that the grant was awarded. The grant may be cancelled if it is not drawn down within this period.
- If you have been unable to start spending a payment within three months of receipt, or it cannot be used for the purpose for which it was awarded, you must inform us of the situation as soon as possible.
- The grant is made in the expectation that each payment is fully spent within 12 months of receipt.
- If the grant is towards salary costs, you must inform us if the post(s) become(s) vacant for more than three months.
- You must inform your Grants Manager in writing (in advance if possible) if there are:
  - Any significant organisational changes (e.g. a merger or proposed transfer of work we are funding to another charity);
  - Changes of key personnel (e.g. the Chair of Trustees, CEO or any post funded with this grant);
  - And of any adverse material developments which may affect the work funded by our grant.
- **A Progress Report is due ten months after each payment is made.** A copy of the Progress Report Form can be found on our website at:

- A copy of your latest Audited/Independently Examined accounts must be sent to us no later than six months after your financial year end.
- You must inform the Henry Smith Charity of any underspend on the work funded, or if other funds are secured towards the work Smith’s has agreed to fund.

- The Trustees reserve the right to require the return of a grant, if at any time during the course of the grant, false information has been knowingly supplied.
- All payments are subject to the necessary funds being available within the Henry Smith Charity.

**The following additional conditions** apply to grants towards **running costs grants**:

A running costs grant has been made to give your organisation as much flexibility as possible in delivering the work the Trustees have decided to support. However, **it is not “unrestricted” as the following conditions apply to how it can be spent:**

1. Each payment of your grant should be spent in a planned but flexible way over a 12 month period (six months if we are providing you with six-monthly payments). We recognise that underspend can occur however; if you have an underspend, please make this clear in your Progress Report. At our discretion we may agree to roll forward any underspend into the next year, thereby extending the total period of the grant.
2. Although your grant is towards running costs, it is **not** to be used towards:
  - a. Redundancy costs;
  - b. Legal fees;
  - c. Significant Capital purchases;
3. You **can** use the grant as a contribution towards the general running costs which may include:
  - a. Staff salaries;
  - b. Sessional staff payments;
  - c. Rent and utilities;
  - d. Other general overheads.

**If the Trustees are not satisfied that these conditions have been met, no further payments will be made.**
